Types Of Funds You Can Open With The AACF



Donor Advised Funds

Most popular type of fund. Often thought of as a "charitable checking account". Donor advised funds allow individuals & families to directly impact their favorite non-profits & programs by making gifts from their fund.



Corporate Advised Funds

Established by companies to be used as a tool to fulfill their corporate giving goals. Reduces overhead on accounting and tax reporting on their charitable giving as it streamlines the process.



Field of Interest Funds

Allows donors to create a fund for a specified broad purpose such as youth, education, animals, etc.

Donors with particular issues of concern or passion may focus their giving by setting up this type of fund.



Agency Funds

Established by nonprofit organizations as an investment strategy for growth. We currently hold agency funds for a variety of organizations including schools, churches, and a wide range of other nonprofit agencies.



Scholarship Funds

Allows the donor to create a fund to assist area students in continuing their education. Donors can choose to set up a fund to benefit students from a particular high school or post-secondary institution.



Investing Back Into Our Community


The Alexandria Area Community Foundation (AACF) and its donors help change lives through a variety of grants to numerous nonprofit organizations. Over \$1.7 million was distributed to non-profits and programs this past year from donors just like you!

Safe Families for Children was awarded \$5,000 to expand their support to youth aging out of foster care, teen parents, youth without family and families with teens who are experiencing a crisis.

support teachers to
purchase necessary
items for their
classrooms through the

Classroom program.





Big Ole Bike Club was awarded \$15,000 to support Cycling without Age Alexandria with the purchase of a Triobike to engage older individuals and those with limited mobility in the hobby of cycling.



Outreach Food Shelf was awarded \$25,000 to support the purchasing of a mobile pantry to expand their reach and provide food in the more remote areas of our community.



Kalon Prep Academy was awarded \$3,000 to provide food support to students through free & reduced breakfast and lunch and the onsite food shelf.

In 2023, the AACF was able to invest \$73,000 in projects through two annual competitive grant rounds that focus on bringing lasting positive change to the Alexandria area.
