THOMAS ANDERSON AWARD IN PHILANTHROPY



The Outreach Programs of Salem Lutheran Church of Deerwood, MN, will receive the 2024 BLACF Global Humanitarian honor for their humanitarian work, not only here but also for their global outreach in Honduras. The award recognizes those who work to improve access to basic needs and enhance lives of global neighbors who may experience extreme poverty or face adverse situations, through giving of their time, resources, and expertise. The Outreach Programs have been doing work in Honduras for over 25 years through the building of infrastructure including; churches, schools, homes, and providing education and ministry to support residents and organizations in need – transforming communities around the world.

John Poston will be remembered posthumously with the 2024 BLACF Legacy Memorial honor for leading a life with a purpose that was bigger than himself and fueled by stewardship and generosity. Poston truly embodied what it meant to be a public servant in all aspects of his life. He was an active leader in the City of Lake Shore, Nisswa and throughout the State of Minnesota. Poston served as Mayor of Lake Shore for four years and was heavily involved in local politics, he also served three terms as District 9A State Representative. Poston founded a humanitarian food-aid organization in 2012, what is now known as, The Outreach Program of Brainerd Lakes (formally Kids Against Hunger). He was a small business entrepreneur who stimulated the economy of the Lakes Area and expanded employment opportunities. Poston leaves a profound and lasting impact, a legacy that will resonate for generations to come; epitomizing his personal values, humility, generosity and kindness.

In a remarkable act of generosity, an anonymous donor of a charitable fund with the Brainerd Lakes Area Community Foundation (BLACF), recently granted \$50,000 to two local nonprofits who are dedicated to supporting the communities most vulnerable. There are two definitions of the word legacy, one definition is an amount of money or property left to someone in a will and the other, is the long-lasting impact of a person's contributions throughout their life. The original fund was established 20 years ago and now, through investment returns, allows the fund successors to provide generous gifts to multiply the incredible impact of nonprofit recipients. This charitable fund embodies both legacy definitions, allowing the fund to support both immediate community needs, as well as future needs.

\$25,000 was gifted to Bridges of Hope's, the Bridge on 7th Overnight Shelter which is a low-barrier warming shelter for individuals 18+ who are experiencing homelessness in the Lakes Area. Guests are offered a safe and warm night's sleep at the 1628 S. 7th Street location, open from 7pm – 8am through the winter season. Adults facing a housing crisis, not only receive a place to sleep, but warm clothing, a to-go breakfast and lunch, and may receive assistance connecting to supportive services. Since opening in late 2021, over 360 individuals have stayed for more than 6,500 nights.

their homeless and recovery resource center in Baxter. The Center offers a supportive, sober, safe environment that assists individuals with putting their lives back together, and providing the necessary resources. Lighthouse Beginnings has a mission to assist and empower individuals who face roadblocks in the recovery process. They are open Monday through Friday, 7:45am – 7:45pm, and on Saturday and Sunday from 8am – 5pm. Open Arms has a community space for activities, a small kitchen for meals, and helpful staff who provide clients support to help increase employee retention and job placements. A woodworking and automotive shop will be added in conjunction with another program housed in the facility, the Fatherhood Challenge.

IDGES OF HOPE PROVIDES MORE




New and exciting things are happening at Bridges of Hope! February marked the opening of the relocated Baxter Common Goods store, which is now just a mile up the road from the previous location, you can find their expanded location at 17140 HWY 371 N, Baxter, from previously. The new location is not the only new thing occurring at the Common Goods stores. All locations are now accepting damaged clothing and fabric for their recycled clothing program (this program received grant funding from BLACF as a Difference Maker in

2023) to increase revenues and provide an option to utilize non-saleable textile items. If you wish to donate items to be recycled, please place them in a trash bag and label "FABRIC RECYCLE".

Incorporated in 2002, Bridges of Hope is a faith-based 501(c)(3) nonprofit organization, servicing communities in and around Crow Wing County. Bridges of Hope provides assistance to those facing a financial or other crisis by connecting them with local human services and support resources. Bridges of Hope, has the three Common Good thrift store locations, provides meals through Operation Sandwich and also manages an overnight warming shelter.

The Bridge on 7th Overnight Shelter is open seasonally from 7pm - 8am for homeless adults 18 years and older. The shelter provides a warm and safe place for individuals to stay during the colder months.





A Partner Fund of the Community Foundation

As a BLACF agency fund partner, Bridges of Hope's reserve dollars are invested in their fund to try and hedge inflation, while providing the nonprofit other partner benefits, including training, connection with other local nonprofits, and exposure of programs.
